Subject: Decentralization of Plan Scheme of the Ministry of Food Processing Industries – reg.

Sir,

I am directed to refer to the meetings held with Banks on 14th June 2007 and 3rd July 2007 regarding the Implementation of the Decentralized Scheme for processing of applications and disbursement of grant of the Ministry's Plan Scheme for Technology Upgradation/Establishment/Modernisation of Food Processing Industries through the Banks/Financial Institutions. In order to sensitize the Officers/Staff of the Banks regarding the processing of the applications and disbursement of grant as per Ministry's guidelines, the Banks were requested to suggest suitable venues for holding Workshops by the Ministry. So far Ministry has not received any suggestions in this regard from any of the Banks. Your attention is also invited to Ministry's letter of 24th August 2007 wherein the Banks were requested to send to the Ministry copies of the Internal Circulars, if any, issued to the Branches for operationalisation of the scheme. You are requested to send copies of the Instructions issued to the undersigned at the earliest.

In respect of fresh applications received by the Banks during the current year under the decentralized procedure, the banks are requested to send to the Ministry details of the cases received in the following format. It may be mentioned that the E-portal is in the final stages and is likely to become operational by mid September 2007.
