Subject: Decentralisation of Plan Scheme of Technology Upgradation/Setting up/Modernisation/Expansion of Food Processing Industries – reg. Applications received after 31.03.2007.

Sir,

I am directed to refer to the Ministry's letter of even number dated 13th June 2007 in which SNAs were, inter alia, requested to forward the applications received by them from entrepreneurs under the decentralized Scheme for Technology Upgradation/ Modernisation/ Establishment of food processing units, to the concerned bank branch from which the unit has availed term loan with a forwarding letter as in **Format III** (enclosed), after providing acknowledgement to the entrepreneur as in **Format I** (enclosed).

2. Although, initially 27 banks were included under the scheme, it has now been decided that all scheduled banks including Co-operative/Commercial/Regional/Rural Banks and Financial Institutions will be covered under the scheme. All the SNAs are, therefore, requested to forward any applications received after 31st March 2007 and which are still pending with them to the respective banks from which the applicant units have taken term loan immediately, under intimation to these units/Ministry. Where term loan has not been availed, it may be sent to the bank of the choice of the applicant units for availing the grant.

3. The Ministry is in process of putting in place an e-portal which will provide interface between bank branch and the Ministry for the purpose of request to the Ministry for transfer of funds in respect of grant approved by branch as well as for transfer of information relating to the applications. It is expected that the e-portal will be operational by the end of this month.
