ORDER

In continuation to this Ministry's order of even No. dated 13.06.2008, the undersigned is directed to say that State level Task Forces have been constituted in many States and a Central Task Force will be set up to be headed by the Union Minister of State (IC) for Food Processing Industries. Further, the revised terms and conditions of the appointment of the Zonal/Regional Chairman will be as below:-

Functions: The Zonal/ Regional Chairman will -

- (a) act as an interface between Central Task Force in the Ministry of Food Processing Industries and the State level Task Force on Food Processing in the State.
- (b) co-ordinate assessing the needs of the entrepreneurs/manufacturing units in the area.
- (c) assess availability of raw material, availability of infrastructure, suggest measures for food safety standards and establish linkages of technology institutions/research organizations.
- (d) act as a Nodal forum and strategic link between the States and the Centre.
- (e) coordinate policy aspects and in that regard maintain regular interaction with State Departments and Industry Associations.
- (f) motivate and generate investments from prospective entrepreneurs for this sector.
- (g) assist in achieving the Vision 2015 of the Ministry and act as catalyst to explore the possibilities of co-operative and contract farming so as to link farmers, processors and retailers together for maximizing of value addition, minimization of wastage and to improve the income of the farmers.
- (h) Zonal/Regional Chairman will co-chair the State task force meetings whenever they attend any State task force meetings.
- (i) The tenure of Zonal/Regional Chairman will ordinarily be of two years which will be extendable by one year.

2. Secretarial assistance will be provided by the concerned State Nodal Agencies (SNA). Adequate funds will be provided by the Ministry of Food Processing Industries in coordination with the SNAs under the SNA grant scheme.

3. TA/DA for the Zonal/Regional Chairman will be regulated as per relevant orders of the Ministry of Finance.

4. No honorarium will be paid to the Zonal/Regional Chairman.
